The Impact



354 families served

We served 134 low-income homeowners and 217 renter families with solar in 2022!

845 kilowatts installed

Our amazing construction team went above and beyond to serve our communities in 2022.



The Financials


Revenue: \$6,918,546

Incentive programs include California state programs like SOMAH and DAC-SASH. Fee-for-service includes TPO (Third Party Ownership) proceeds as well as contracts with government and nonprofit entities. Fundraising revenue includes philanthropic donations and other funding awarded through a competitive grant process.



Expenditures: \$6,601,707

Administrative costs include facility expenses such as rent, utilities, and office supplies. Programmatic expenses include project personnel, equipment, solar and training materials, and travel.





Energy for AllSingle-Family Solar



A Stockton resident of 55 years, Ms. Audrey (pictured below center) volunteers at her local community center three times a week, and takes line dancing classes at another nearby community center twice a week. Through her community activity, she connected with GRID partners from Stockton's Transformative Climate Communities Program (TCC), a statewide initiative that puts billions of Cap-and-Trade dollars to work reducing greenhouse gas emissions, strengthening the economy, and improving public health and the environment – particularly in disadvantaged communities.

At no cost to her, Ms. Audrey received a partial re-roof and solar installation from GRID with TCC funding in June 2022. She is looking forward to the \$600 of annual savings her new solarized and energy-efficient home is expected to provide, an 84% reduction of her electrical bill. "I need all the improvements I can get because I can't afford to pay for it," Ms. Audrey told us, as she lives on a fixed income. "I like to go places. I like to do things. So I need to save some money to do that, and every penny helps."

Workforce Development



GRID's workforce development team had a busy 2022 - from piloting our first satellite cohort in Stockton (bottom right picture) to transitioning back to on-the-roof training after a 2-year pandemic pause. We had the most Installation Basics Training (IBT) graduates this year since launching the program in 2019.

Darius and Donovan, a father and son duo from Sacramento, completed IBT in April. Darius told us, "My son just graduated from high school, and I thought this would be a good opportunity for him to see what's out there other than college because I realized college isn't for everyone. I wanted him to see how solar could be a path for him, and it's something we could do together." Since graduating, both Darius and Donovan have been working for a friend's solar panel cleaning business!

Energy for AllCommercial Solar



Developed by the Sacramento Redevelopment and Housing Authority (SHRA) and funded by the California Strategic Growth Council's Transformative Climate Communities program (TCC), GRID's solar installation serves 104 families and provided clean energy workforce development opportunities for residents.

This multi-family affordable housing project will prevent the equivalent carbon emissions of 9,000 trash bags of waste from going to landfill. Solar will offset Mirasol Village's energy costs in common areas, which can then be channeled back into programs and resources for tenants, including a job board, community garden, playground, and more!
